**Exhibit A—Log Documenting the Refusal of Entry to or Ejection of an Individual from District Property**

In accordance with [Education Code 37.105](#), each district will maintain a record of each verbal warning issued, including the name of the person to whom the warning was issued and the date of issuance, when a school administrator, school resource officer, or school district peace officer refuses entry or ejects a person who refuses to leave peaceably on request and continues to behave in a manner that is inappropriate for a school setting.

### **Exhibit B—Notice of Refusal of Entry to or Ejection of an Individual from District Property**

To: *(Name of person refused entry to or ejected from property)*

In accordance with Education Code 37.105, you are being refused entry to or ejected from property under the control of \_\_\_\_\_ School District because you have refused to leave peaceably upon request and either posed a substantial risk of harm or continued to behave in a manner that is inappropriate for a school setting after being given a verbal warning.

You will be refused entry for a period of \_\_\_\_\_ *(may not exceed two years)*.

You may appeal this action by filing an appeal under FNG(LOCAL) or GF(LOCAL) at the links listed below. A person appealing under the District's grievance process shall be permitted to address the Board in person within 90 days of the commencement of the appeal if the grievance is not resolved at a previous level.

### **Exhibit C—Website Notice Regarding the Refusal of Entry to or Ejection of an Individual from District Property**

In accordance with Education Code 37.105, the District has the right to refuse entry to or eject a person from property under the District's control if the person refuses to leave peacefully upon request and:

1. The individual poses a substantial risk of harm to any person; or
2. The individual continues to behave in a manner inappropriate for the school setting after having received a verbal or written warning to cease the inappropriate behavior.

A person ejected from or refused entry to District property under this provision may appeal this action by filing an appeal under FNG(LOCAL) or GF(LOCAL) and shall be permitted to address the Board in person within 90 days of the commencement of the appeal if the grievance is not resolved at a previous level.
